Objective: To gain a clear understanding of options and educated decision(s) whether to grant the original location that meets the 660' zoning requirement with safety concern, or

if property owner decides to proceed with a request for a variance from Carver County that would address the safety concern noted by the road authority by granting access 550' from Co Rd.

 - No edits needed staff to proceed with sending along with copy of ordinance

Board Member Reports

Vice-chair Cathy Nielsen:

- Reviewed the Pending Business List
 - (Rosin) Supervisor Parris spoke with Rosin about easement matter, confirmed that property owner met with PW staff to confirm understanding of requirements, and projected to be completed by mid to end of June.
 - (Annexation of TRP/CPR) Supervisor Parris attended City of Victoria meeting 5/8 and witnessed the vote pass to approve annexation of the Three Rivers Park/Carver Park Reserve parcels from Laketown Township to the City of Victoria, noting only 1 "no" vote.
 - (Augusta Rd) Clerk/Treasurer Kunze confirmed there has been no communication received from residents in response to the letter sent informing them of plans to return to gravel in 2024 unless residents accept assessment for asphalt. Supervisor Parris spoke with a Board Member from Dahlgren Twp about the entrance to Little Av off of the intersection with Co Rd 140 (location where 4 townships come together) and will connect with a representative from Benton Twp re: possible cost share (~\$9,000) for the repair work recommended by engineer.

- (Unauthorized contents in 201 Sewer) Clerk/Treasurer will consult with Deputy Lano for 0 process to follow if a public hearing is required in addition to publishing requirements relating to proposed ordinance to amend existing 201 Sewer Ordinance.
- Question raised regarding \$250,000 limit for FDIC and whether Laketown Township's funds were protected.
 - Clerk/Treasurer provided information related to the annual collateral statement we obtain 0 from Security Bank to ensure all funds are protected. Noted this is also a part of the annual audit to ensure we have this statement from our bank.

Supervisor Pete Supervisor Parris:

- PW staff and representative from Carver County went to look at 9530 Lakewood Circle and noted how the property owner made changes to the contour of the landscape contributing to the drainage concerns raised by the property owner.
- Attended St. Boni Fire Advisory Meeting they are ordering a new truck * two years out (approx. \$1m)

Clerk/Treasurer Kunze:

- Spring Composting went well. Steady flow on Tuesday and Thursday, and staff reports Saturday quite
- Will reach out to Bolton & Menk for status update on the Sewer Feasibility Study and preliminary presentation to the Board.

Reviewed items listed under FYI/Correspondence

It was noted that the Ford redesign and repair notice happens to acknowledge and address the steering issue PW staff had recently reported impacting the F550.
